CALL TO ORDER: Mayor Bob Gibbs called the meeting to order.

INVOCATION: Chaplain Jason Hines gave the invocation.

PLEDGE OF ALLEGIANCE: Landon Hines and Gracie Steelmon led the Pledge of Allegiance.

ADOPT AGENDA: Mayor Gibbs asked for a motion to adopt the agenda.

Donnie Potter made a motion, and Joe Wesson seconded, to adopt the agenda. All were in favor.

APPROVE JANUARY 15, 2013 REGULAR MEETING MINUTES: Mayor Gibbs asked for a motion to approve the January 15, 2013 regular meeting minutes.

Johnny Wilson made a motion, and Donnie Potter seconded, to approve the minutes. All were in favor.

APPROVE FEBRUARY 12, 2013 SPECIAL BUDGET RETREAT MINUTES: Mayor Gibbs asked for a motion to approve the February 12, 2013 Special Budget Retreat Minutes.

Donnie Potter made a motion, and Joe Wesson seconded, to approve the minutes. All were in favor.

PUBLIC COMMENT: Mayor Gibbs asked if anyone wished to speak during public comment.

No one wished to speak.

RECOGNITIONS:

RECYCLE REWARDS WINNER: Town Administrator Seth Eckard announced Toni Thompson as the January Recycle Rewards winner. A credit of twenty-eight dollars (\$28.00) will be added to her sanitation bill and her certificate will be available at the Town Hall for pick up.

SAWMILLS VOLUNTEER FIRE & RESCUE DEPARTMENT AWARDS: Mayor Gibbs, on behalf of the Town Council, presented plaques of appreciation to the following:

FINANCIAL MATTERS:

REQUEST FOR DONATION TO CALDWELL HERITAGE MUSEUM: Mayor Gibbs stated that the Caldwell Heritage Museum has requested a donation.

Donnie Potter made a motion, and Joe Wesson seconded, to give a donation to the Caldwell Heritage Museum in the amount of \$250.00. All were in favor.

BID AWARD FOR STREET IMPROVEMENTS: Mayor Gibbs stated the town has received the following five bids, for the street improvements project:

Jeff Wilson made a motion, and Donnie Potter seconded, to award the bid to Evans Construction in the amount of \$178,568.94, as they were the lowest bidder. All were in favor.

BID AWARD FOR AN ADDITION TO PUBLIC WORKS STORAGE BUILDING: Mayor Gibbs stated the town has received the following seven bids, for an addition to the Public Works storage building:

There is \$150,000.00 included in the budget for this project and Mastercraft Log & Custom Homes, L.L.C. has agreed to lower their bid to that amount.

Donnie Potter made a motion, and Joe Wesson seconded, to award the bid to Mastercraft Log Homes, L.L.C. in the amount of \$150,000.00, as they are the lowest bidder. All were in favor.

DISCUSSION:

ADOPT AGREEMENT WITH NCDOT FOR 321-A BRIDGE REPLACEMENT: Mayor Gibbs stated the North Carolina Department of Transportation (NCDOT) plans to replace Bridge No. 6 over Little Gunpowder Creek (the bridge that connects Sawmills and Hudson) on US 321-A with a proposed start date of January 21, 2014.

Joe Wesson made a motion, and Jeff Wilson seconded, to adopt the enclosed agreement with NCDOT for 321-A bridge replacement. All were in favor.

ADOPT INTERLOCAL AGREEMENT WITH CALDWELL COUNTY FOR THE NATIONAL FLOOD INSURANCE PROGRAM: Administrator Eckard stated by adopting the enclosed Interlocal Agreement with Caldwell County, the Town of Sawmills will be responsible for the National Flood Insurance Program and the county will only administer the program on behalf of the town.

Donnie Potter made a motion, and Joe Wesson seconded, to adopt the Interlocal Agreement with Caldwell County for the National Flood Insurance Program. All were in favor.

ADOPT STORMWATER DISCHARGE PROGRAM AGREEMENT WITH CITY OF LENOIR: Mayor Gibbs stated the current Stormwater Discharge Program Agreement between the City of Lenoir and the Town of Sawmills needs to be renewed. The enclosed agreement will renew the Stormwater Discharge Program Agreement for the period of July 1, 2013 to June 30, 2014.

Joe Wesson made a motion, and Jeff Wilson seconded, to adopt the Stormwater Discharge Program Agreement between the City of Lenoir and the Town of Sawmills in the amount of \$13,104.93. All were in favor.

ADOPT RESOLUTION DESIGNATING MARCH AS CALDWELL COUNTY AND TOWN OF SAWMILLS HISTORY MONTH: Mayor Gibbs stated Caldwell County adopted a resolution designating the month of March each year as Caldwell County History Month and invited all towns within the county to join them.

Donnie Potter made a motion, and Joe Wesson seconded to adopt the enclosed Resolution Designating the month of March each year as Caldwell County and Town of Sawmills History Month. All were in favor.

ADOPT RESOLUTION OFFERING EMPLOYEES ADDITIONAL HEALTH INSURANCE OPTIONS: Administrator Eckard stated that currently town employees only have one option for health insurance and the enclosed resolution allows them additional health insurance options to reduce their out of pocket expense.

Donnie Potter made a motion, and Johnny Wilson seconded, to adopt a resolution offering employees additional health insurance options. All were in favor.

PUBLIC COMMENT: Mayor Gibbs asked if anyone wished to speak during public comment.

David Powell and David Massie spoke in regards to the recent re-evaluation that was done by the county, which changed the amount citizens pay in property tax.

Discussion:

As you may recall during the Budget Retreat on February 12, 2013, Council discussed the duties of the Town Administrator.

Section 31.03 of the Town's ordinance states: "The Town Council shall appoint a Town Administrator whose duties shall be to generally oversee the administration of the town staff and town affairs as so directed by the Mayor and Town Council. The Town Administrator shall serve at the pleasure of the Town Council and receive compensation from time to time as may be prescribed by the Town Council."

The enclosed resolution to amend Section 31.03 of the Towns ordinance will change the duties of the Town Administrator to state: "The Town Council shall appoint a Town Administrator whose duties shall be to execute and administer the policies and procedures as adopted by the Town Council. The Town Administrator shall be responsible for the preparation of a budget, keeping the Town Council advised of the status of the affairs of the Town, establishing sound positive public relations between the Town and its citizens, between the Town and other governmental agencies and between the Town and other boards and Commissions as directed by the Town Council. The Town Administrator has all hiring and firing authority for employees with the exception of the Finance Officer. The Town Administrator shall hire, evaluate and direct the Town's staff in accordance with the Personnel Policies as adopted by the Town Council. The Town Administrator shall serve at the pleasure of the Town Council and shall receive compensation from time to time as may be prescribed by the Town Council."

Recommendation:
