Mayor Keith Warren stated that Town Code Enforcement Officer Curt Willis has drafted an Ordinance Directing Town Officials to Vacate And Close 2520 Sigmon Dr, Granite Falls, NC (NC Pin 2775357123) As An Imminent Danger To The Public And Directing That A Notice Be Placed Thereon That The Same May Not Be Occupied. Mayor Keith Warren stated that the owner of the property is deceased and there are homeless people living in the residence.


