ADOPT PROPOSED RESOLUTION IN SUPPORT OF DEDICATING THE REPLACEMENT BRIDGE ON 321-A TO A FALLEN FIREFIGHTER: Mayor Gibbs asked the family of Chad Settlemyre, Sawmills Fallen Firefighter to come forward. Mayor Gibbs stated that the Resolution in Support of Dedicating the Bridge in 321-A to Chad will have to wait until the regular Council meeting in August.

Attorney Terry Taylor stated that the North Carolina Department of Transportation requires the resolution to include information about some of Chad's accomplishments in reference as to why the Town supports dedicating the bridge in his name. Attorney Taylor will contact Mrs. Settlemyre to get information to include in the resolution. The Hudson Town Council will also need to adopt a Resolution in Support of dedicating the bridge in Chad's name as part of the bridge is in Hudson.

Mrs. Settlemyre stated that Bemis, the company Chad worked for is going to cover all costs associated with this dedication so there will be no cost to the Town.

Joe Wesson made a motion to approve a budget amendment in the amount of one-hundred thirty-six thousand dollars (\$136,000.00) for the construction of restrooms at Veterans Park. There being no second the motion does not carry.
